1901-1918	No restrictions on FDI	Foreign companies were engaged in various trading activities
1919-1942	Duties were levied on Imports	A few companies invested in local manufacturing in India

1943-1961	Second Five Year Plan	operations in India.
	Industrial Policy, 1947 and 1956	Nearly 60 US firms invested in Sales & Marketing

1962-1977	Industrial Licensing Guidelines, 1969; MRTP Foreign Exchange Regulation Act, 1973	Over 60 companies (including IBM & Coke) ceased operations in India
1978-1990	Industrial Licensing Policy, 1977 and 1980	Limited response to investments in India
1991-2000	Industrial Licensing Policy, 1991	Flooding of foreign investments
	Foreign Exchange Management Act, 1999	Increased investments in services sector
